



Announcement of Chiang Mai University

Subject: The List of Accepted Candidates for Graduate Studies First Semester, Academic Year 2026

Chiang Mai University would like to announce that the following candidates (**852 persons**) have passed the admission process and are eligible to register for the first semester of the academic year 2026 (Round 1) (starting from June 2026) as in the attached list.

1. Registration as a student

The above accepted candidates must register as a student and finish the tuition fees payment in accordance with the relevant Chiang Mai University regulations. Only upon completion of these steps by the specified date and time will the registration be considered complete and valid.

If selected for more than one major, applicants may register, but only for a combination of one track 1 major (regular time schedule) and one track 2 major (special time schedule). Dual registration in two track 1 major (regular time schedule) or two track 2 major (special time schedule) is not allowed.

2. Date, time, tuition fee payment, and registration process

The registration system can be found at <https://stdinfo.reg.cmu.ac.th/graduate/index.php>. The system will be opened on March 18, 2026, at 08:30 AM (UTC+07:00). The candidates must fill out the form, submit and finish the tuition fees payment within 11:00 PM (UTC+07:00) of March 18, 2026. Those who fail to register within the specified deadline will be considered waiving their offers of admission, and the University will call upon alternate candidates to register (if any).

3. Required Documents for Registration

Accepted candidates must submit all relevant evidence for the university-designated registration on the scheduled date and time. If the evidence is not complete, the university will not accept the registration, except for those who expect to graduate in second semester, academic year 2025, and will be completely graduate before the first day of semester, in accordance with Chiang Mai University's Academic Schedule (June 22, 2026). They will be allowed to submit the graduation evidence within the first semester of studying.

Accepted candidates must upload the following documents into the registration system on the Registration Office website.

3.1 **Front-facing photo for ID card:** (JPG files only)

3.2 **Identity verification photo:** A front-facing photo taken together with a national ID card (or a passport in case of non-Thai citizen) is required for identity verification. (do not write or strike out any

3.3 Complete version of transcript: (PDF file only)

- For those who have graduated, a PDF scan of an original Transcript or digital document issued by the academic institution, showing a graduation date of their bachelor's degree or master's degree is required.

- For those graduating in the second semester of the academic year 2025, a PDF scan of the latest version of their transcript or digital document issued by the academic institution of their bachelor's or master's degree must be submitted.

Note: For foreigner (non-Thai citizen):

- Submit the English version of the official transcript and the official transcript in the original language (if available).

- Selected international candidates are required to upload their passport in the registration system. If a passport is not yet available, the university will grant a temporary deferral for its submission.

Note:

- 1) Once a selected candidate has complete the registration process and a CMU account has been created. The student will be able to access the internet and library services. Health services will be available after the student has completed course enrollment or university service enrollment.
- 2) If a selected candidate is unable to complete the online registration process by the specified date, they must inform their department/faculty/institute/college, who will then notify the Registration Office to request a special extension for late registration.
- 3) Government officials or personnel who have been selected for admission to a regular program must submit a referral letter and a leave approval letter from their organization directly to the faculty/institute/college where they have been admitted.

4. Student Enrollment Fee

Accepted candidates must pay the tuition fee of the first semester, academic year 2026 as a package payment one semester or year-based program on the student registration day. Exceptions may apply to students who meet the specified criteria for "readmission to Chiang Mai University" They must submit a Checklist for Graduate Program's Consideration of Student Readmission to the department at least 7 working days and pay the full tuition fee.

Payment Methods:

4.1 QR Payment via mobile banking

4.2 Credit card payment via computer network (plus 2.1% transaction fee)

4.3 Alipay or WeChat pay (plus 1.7% transaction fee)

4.4 Direct Payment at Finance Division, Office of the University, by one of the following methods:

- Debit Card Payment (no transaction fee), please make sure that the bank account limitation covers the balance to pay
- Credit card payment (plus 0.9% transaction fee)
- Cashier's Cheque (payable to Chiang Mai University)

***Please note that tuition fees once paid are non-refundable.**

**** Scholarship recipients are required to contact their respective department/ faculty/ institute/college at least 7 working days before the registration date. This contact is required to prepare a letter requesting the deferral of the tuition fee payment on the registration day, which must be submitted to the Registration Office.**

5. Request for a student ID card

Students are able to apply for a student ID card through the SCB Easy App, approximately 2 weeks after completing the registration process. After applying for a student ID card through the SCB Easy App, the bank will send the student ID card within 2-3 weeks of the request.

6. Schedule of Enrollment and First Day of Class

After completing registration, students are required to enroll for courses or enroll for university services as indicated in the academic calendar.

If any information provided in the student registration documents is found to be false, or if any documents uploaded to the registration system are forged or altered, the university will immediately revoke the right to study. Furthermore, those who fail to complete the student registration process within 14 days from the registration date **will be considered as having waived their right to study at Chiang Mai University.** **For waitlisted candidates, the university will notify them to register when vacancies become available due to declined admissions.
